Up to 3 colonies are included in the Registered and Junior subscription. Additional premiums may be paid as follows:

4 to 5, +£2:00	6 to 10, +£5:25;
11 to 15, +£7:75	16 to 20, +£9:50;
21 to 25, +£11:10;	26, to 30 +£13:60;
